

## **WSIPC RFP 22-03 Notification System Solutions**

## RFP Bid Addendum I

The following corrections, questions, and clarifications are provided concerning WSIPC RFP 22-03, Notification System Solutions. Paraphrasing of the relevant questions posed to the WSIPC RFP Contract Administrator have been included as appropriate.

## **QUESTIONS AND CLARIFICATIONS:**

- **Q1** It is unclear to me if this is requesting academic enrichment software/technology solutions or what specific technology use is this RFP seeking to accomplish.
- A1 Please refer to Section 1 Introduction; RFP Description. Noting, "provides a cloud-based <u>mass notification system</u> in accordance with the specifications contained in this RFP".

**RFP Description:** Effective and efficient communication tools for schools and public agencies are an ever evolving challenge. Quick and reliable delivery of information plays a crucial role in safety, well-being, and message understanding.

WSIPC is releasing RFP 22-03 to establish relationships with one or more vendors that provide a cloud-based mass notification system in accordance with the specifications contained in this RFP.

- **Q2** Could WSIPC please advise what type of evidence is acceptable in response to item 3.3.2 on page 17 of the RFP, restated below? Would it be acceptable to provide references for customers that show the \$500K minimum?
- A2 A list of References and a list of customers that you attest meet the combined minimum of \$500K would be acceptable.

- **Q3** The Proposer must describe their experience in providing product and/or services. This includes their experience providing services to the educational or public sector. Each Proposer shall include evidence of minimum sales of \$500,000.00 in the last 18 months to educational and public sector customers.
- A3 A list of public sector and educational customers that you attest meet the combined minimum of \$500K would be acceptable.
- **Q4** Regarding Appendix B, Proposal Form, do we have to complete the representative acknowledgement Section and is it meant for a notary to sign?
- A4 Yes, you must complete Appendix B; a notary is not required. The qualified signor may use a PDF signature tool and or sign a printed copy to submit.
- **Q5** Would a gunshot detection system on an emergency notification platform be eligible for the RFP 22-03 Notification System Solutions category?
- A5 In keeping with Section 1.1 General Invitation of the solicitation document, if the solution meets the RFP Description and provides a cloud-based mass notification system and aligns with the specification contained in Appendix D Product-Service Requirements, it is eligible. "Emergency" is considered a type of Notification System Solution. (note below)
